The Guidelines apply to all parts of the service, including content, behavior, servers, and apps. Our <a href="#">Policy Hub</a> expands on these Guidelines, providing more information about our policies.</p> <p>Discord is where people hang out before, during, and after playing games. For Discord's DSA Transparency Report, we have combined our reported metrics across Discord. But Discord provides multiple ways for users to communicate, some of which constitute an Online Platform under DSA, and others which are a Hosting Service.</p> <p>We work hard to create an online environment that users want to be a part of and spend their time enjoying. To do that, we follow a three-tiered approach:</p> <ul style="list-style-type: none"><li>· User Controls: Discord's product architecture provides each user with control over who they communicate with, what they see, what communities they join.</li><li>· Platform Moderation: Our community guidelines are enforced by Discord's Trust &amp; Safety team through a mix of proactive and reactive measures, supported by tooling and ML. For further discussion of those tools and methods, see Discord's response to Question 3E below.</li><li>· Community Moderation: Server owners and community moderators, aided by moderation bots, define and enforce Community norms and behavior that go beyond the Discord Community Guidelines.</li></ul> <p>This is also seen in our publicly available article about our <a href="#">Approach to Content Moderation</a>.</p> <p>All users have the ability <a href="#">to report behavior to Discord</a>. User reports are processed by our Trust &amp; Safety team for violative behavior so we can take enforcement actions where appropriate. When we see content that violates our policies, we take the appropriate action based on the severity of the violation. The result of our actions are conveyed to users through our <a href="#">Warning System</a> and include:</p> <ul style="list-style-type: none"><li>· Warning to the user that future violations may result in more severe consequences;</li><li>· Restricting user access to features (e.g., inability to send images on Discord after sending an image that violated a Discord policy);</li><li>· Content removal;</li><li>· Temporary suspension of user account;</li><li>· Permanent ban of user account.</li></ul> <p>When a server is focused on or contains a lot of content that violates our policies, the owner of the server will receive a violation and the server may be removed or restricted. Just like user violations, the server owner will be provided a summary of the violation with more detail.</p> <p>Discord is also committed to working with industry partners and other organizations to support its safety efforts. Our <a href="#">Safety Reporting Network</a>, features a global partnership of trusted organizations who collaborate directly with Discord's Safety team. Discord also contributes to and participates in industry-wide efforts such as the <a href="#">Lantern</a> initiative, a first-of-its-kind signal sharing program for companies to enhance and strengthen how they detect attempts to sexually exploit and abuse children and teens online.</p>

Human moderators may perform secondary reviews to validate flagged content and address nuanced or context-specific cases.</p> <p>Discord also works hard to proactively identify harmful content and conduct so we can remove it and therefore expose fewer users to it. We work to prioritize the highest harm issues such as child safety or violent extremism.</p> <p>We use a variety of techniques and technology to proactively identify harmful behavior, including:</p> <ul style="list-style-type: none"><li>· Image hashing and <a href="#">machine-learning powered</a> technologies that help us identify known and unknown child sexual abuse material. We report child sexual abuse and other related content and perpetrators to the National Center for Missing &amp; Exploited Children (NCMEC), which works with law enforcement to take appropriate action.</li><li>· Machine learning models that use metadata and network patterns to identify bad actors or spaces with harmful content and activity.</li><li>· Human-led investigations based on flags from our detection tools or reports.</li></ul> <p>We may use automated means to proactively identify harmful content on the platform and enforce our <a href="#">Terms of Service</a> and <a href="#">Community Guidelines</a>.</p> <p>As we continue to evolve our proactive efforts, our focus is on developing technologies to aid in the detection and removal of this harmful content as quickly as possible while respecting our users' privacy.</p> <p>For example, we have a dedicated team that has created and is now utilizing a new <a href="#">machine learning model</a> that can detect previously unknown CSAM, and we have made this technology more widely available via open sourcing. We will continue to innovate and collaborate with industry partners to address emerging challenges, and we collaborate closely with organizations like the National Center for Missing &amp; Exploited Children (NCMEC) and Internet Watch Foundation.</p> <p><b>Measures of Exposure</b></p> <p>Discord users often rely on the platform to talk and hang out with their friends while playing games. Users look to Discord's subscription offering, Nitro, to enhance their experience with features like improved streaming quality or more ways to express themselves while messaging with friends. This communication often happens in real time such that Discord does not track the number of times a user may "view" a piece of content. Discord has developed methods to assess the effectiveness of its content moderation practices across its policies. These measures are robust, and assess the factors such as the responsiveness to user reports and the prevalence of harmful content on the platform. Discord has evolved its content moderation systems and practices as a result of DSA implementation.</p>
