Context

To begin, I want to say that if you are going to read this document, please try to read the whole thing. There is a lot of context around everything that's happening so I want to make sure you get the full picture of everything from my point of view.

Of course I have my opinions on the matters discussed here, but I'll also try to tell things as objectively as possible while still giving my own thoughts and opinions.


To start, this document is going to be largely about Needyhenry (or Henry), Kazu (Henry's close friend/moderator), and how I (Ant/antgameplayer) had a falling out with them.

Quick summary of what happened:


1. I met Henry in 2024 through Twitch and Henry introduced me to Kazu in the same year. I went on multiple hang outs and dinners with Henry, Kazu, and some others, where Kazu was always paying for the whole group.
2. In the same year, I started being wary of Kazu when he told me that he had a talking phase with someone who was 18 when he was 28-29. On top of this, he also spoke about working for a Trump-supporting company and made remarks about supporting Trump himself.
3. Even though I personally held a dislike for Kazu since knowing that information, I told myself that it's no harm to go to dinners here and there since they were going to be paid for. However, the last time I saw Kazu was March 1st, 2025. 11 months ago.
4. During a stream a few months ago, I discussed my dislike for a mutual friend (Kazu) that I had with other members of the community. Those viewers, of

course, deduced I was talking about Kazu since they knew who he was as well, despite me not saying his name.

5. On January 12th of this year, Henry dm'ed me, saying that he knew I was talking ill about Kazu behind his back and said that I was only using Kazu for free food, and that he and the group were going to cut me off. I apologized to Henry for talking ill of Kazu behind his back, but stood my ground about why I did, mentioning his history of predatory messages and Trump-supporting statements. Despite providing screenshots and evidence, Henry brushed my concerns off under the guise that Kazu is always "just trolling" and that if I had known Kazu better, I wouldn't be making these assumptions.
6. Our conversation ended with Henry saying that he doesn't have anything else to say and states that Kazu doesn't have any bad intentions in all the years they've known each other (since 2020). It's worth mentioning that Kazu was 28-29 when they met, while Henry was just 17-18.
7. Later, word got out about what happened between me and Henry, and Henry sent the message below in his server (which I'll dive deeper later in the document):



8. Henry then started to ban members of his community that are seen “supporting” me, even members who have been loyal viewers of his for some time.
9. Henry also started bringing up the situation to other Twitch streamers in their chats, who are not, in any way, involved with me or what’s going on. He publicly criticised and bashed my character, saying I’m stirring up drama and clout-chasing from this situation. It’s worth to note at this point that I have only been interacting with the conversations in my own server, I have not reached out to anyone or chatted in any other streamers’ chats/servers about the situation, trying to “spread rumors” as Henry is saying.



10. Now, I have decided to make my own statement to publicly give my side of the story.

However, before I dive into what I have to say, I want to give two reasons why I’m addressing things the way I am:

1. Henry has made this situation very public when he blocked me for calling out Kazu. Henry and I share a lot of the same community members and viewers so he must have known that word was gonna spread. If he blames me for talking to people about it, why



would I not? I was dm'ed out of the blue to be cut off over a problematic individual by someone who I thought was a good friend. Anyone in my situation would have also talked to their friend groups about it. On top of that, Henry has also released a public statement about me, banned people from his server/stream for siding with me, and bashed my character in other Twitch streamer's chats. At this point, I feel like I have to publicly address this not only to clear my name but my community's name as well.

2. This situation also involves issues regarding the safety of online spaces that are much bigger than both Henry and I. For Henry to protect and even cut ties with people over an individual who has shown predatory behaviors in the past WHILE still holding a very large online community where said individual has been an active member for the past 5 years, raises a lot of concerns for the people in the community, especially minors, that I feel are definitely worth addressing.


Kazu

First, and arguably most importantly, I need to address Kazu, Henry's close friend and moderator that he is cutting me off for talking shit about, the center of this conversation. As I have said before, Kazu told me he had a talking stage with an individual who was 17-18 when he was 27-28 in 2024 when I first met him. Then, about two weeks ago (before Henry even dm'ed me), I was shown evidence of things Kazu had said online to minors that were very pedophilic and predatory in nature. I will show the screenshots of these incidents here. Keep in mind these screenshots are from the past and to pay attention to the date when each message was sent (the dates are in the format day/month/year/time).




User “Voe-Nara”, or “bibi” as he was called in the server, tells Kazu he is 16 in the first screenshot and, in the second screenshot, another user informs Kazu that bibi is not 18+. Kazu is seen responding to both of these messages, therefore fully acknowledging that Bibi is a minor.

Then, Kazu responds to Bibi's face reveal by calling him “ACTUALLY CUTE AF”. Kazu also says he can't wait to see Bibi on webcam and asks for Bibi's Snapchat account, all while knowing he is 16. At this point, it's worth questioning what Kazu's intentions are for wanting to add a 16 year old on Snapchat, since he can already send regular messages and pictures on Discord.

It's also worth noting that Bibi asks for the age of consent in Canada, which Kazu confirms to be 16, yet continues to talk about the age of consent being even lower if the parents consent, and that the age of consent for intercourse is still 18. Although this is not incriminating, it's still odd that Kazu continues to talk about how low the age of consent could get to a server of minors despite knowing their age and being 27-28 himself during this time.



Kazu, in the first screenshot, requests to meet up with Bibi in LA and share an airbnb together with him. This happened 34 minutes after Bibi revealed his face.




Kazu also, on a different occasion, also asks Bibi to meet up with him in a different country when Kazu is traveling, while knowing Bibi is 16.

Another thing worth noting in the first screenshot is how Kazu offered to buy plane tickets for those who were willing to meet up with him, showing a pattern of Kazu using his money as a way to convince others to hang out/meet up with him.



In the first screenshot, Kazu is talking about an individual named “Tricky” in April 2025 noting that they were 15 when they supposedly “sexualized” things that Kazu has said. Note that the first screenshot is last year and the second is from 4 years ago.


In the second screenshot, Kazu is seen saying “TRICKY GONNA MOLEST ME IN MY SLEEP” insinuating that Tricky, who now we know was a minor at the time, would touch Kazu in his sleep (this is AFTER Kazu invited a bunch of minors to an airbnb). Now I’m not 100% sure if Kazu knew Tricky was 15 back in 2021, but if he did and still said something like this, it would clearly show how weird his thought process is with minors.



In these screenshots, user “Minh” reveals their age to be 18. Knowing this, Kazu proceeds to offer his address to Minh and even asks to meet up with Minh later on. It’s worth to note that he’s specifically addressing Minh by name in these messages, showing that Kazu is not just planning a group hang out or offering to meet Minh with other people, but specifically targeting Minh for a one on one meet up. Kazu is 33 as of 2025.

All of these instances were only captured because they happened in a public space. There’s no telling what else Kazu has said to minors in dm’s or private channels or even in person. Regardless, I believe these screenshots are more than enough evidence to prove that Kazu has had a history of pedophilic and predatory behaviors in the past.

Before we move on, it's also worth noting that Kazu is currently suggested to be romantically involved with a Vtuber whose online persona is shown below:



Note: Kazu is currently around 33-34.

Furthermore, Kazu has always been very outspoken about working for a company that openly supports Trump and even claims to support Trump himself in both online and real-life conversations. Henry has stated multiple times that Kazu is just “trolling” or “rage baiting” but to proudly associate yourself with a company that supports Trump and be so outspoken about being a Trump supporter in communities filled with queer people and POCs is very offensive and harmful. On top of that, Henry’s excuse that Kazu is just “trolling” is a dismissive excuse as no one finds the things he says entertaining or funny besides Kazu. There are people whose lives and rights are actually affected by Trump and his politics, so even to pretend to support him as a “joke” is very problematic

and insensitive in itself. Even if Kazu and Henry are Canadians, they are both very active members in a community with large audiences, and these words and actions, even as “jokes”, can be very harmful, especially knowing that Henry's community is both young AND, once again, largely filled with LGBTQ+ members and people of color.

Before I dive deeper into this section, I want to preface it with the fact that, unlike with Kazu, my main issue with Henry was how he reacted to the situation, and less of him as an individual. I used to consider Henry a close friend of mine and have known him to be a good-hearted person during the time I knew him. I am disappointed in the way our friendship has ended and even more disappointed in the way Henry is handling its aftermath. At the end of this, I only hope that he can not only see my side of the story, but also learn from what's being said here.

When I showed Henry the information I mentioned above about Kazu, he was quick to dismiss them as shown below:





Henry just because he lied about being a minor does not excuse Kazu responding like that... At that time kazu was presented with the fact that he was a minor and still flirted with him and even asked to share an Airbnb with him.

Henry then said this after I expressed concern that Kazu met Henry when he was 18.



Despite Henry saying Kazu was 27 when Henry was 18 (in 2021). Here is a screenshot of Kazu saying he is 29 in 2021. Which begs the question of whether Henry just doesn't know Kazu's actual age, or if he's trying to make Kazu's age seem smaller to excuse his weird behavior.




Henry then concluded our conversation by saying he can excuse Kazu's behavior because he has "known [Kazu] as a person for years and can say that he is truly genuine and cares a lot about the ppl he is close with and is really thoughtful" and that "[Kazu]'s never had bad intentions other than getting ppl mad for fun."

At this point, many members of Henry's online community have reached out to him to express the same concerns about Kazu, as they have also known him to be problematic in the ways I have mentioned and even ways that I have not. Henry, in response, has either dismissed these concerns in the same way he has dismissed mine or just outright bans the person who reached out to him about it. At the same time, Henry is still

banning people who associate themselves with me, including many people who have not interacted with him in a long time. I can only assume that he is doing this as a preemptive safety measure to make sure people don't go to his communities to spread what he is calling "false rumors". On the other hand, I have yet to ban anyone from my Twitch or server, as I believe there is nothing to hide.

Now, I'll circle back to Henry's public announcement in his Discord server that he posted after word got out about the situation. I will dissect it here and point out many fallacies that further show how dismissive and contradictory Henry has been towards the situation. On top of that, I'll try to defend my name and community's name against the points he's trying to make.





After reading the points that Henry brings up in his message, I want to note several important things:

1. Despite him saying that I am “spreading false allegations”, I have personally never gone to other streamers’ chats or servers to talk about this situation. Once again, I have never asked or even pressured anyone to spread news about this situation to any community. People have only done so on their own accord.
2. Henry states that me, Ahmed, and Prax are currently unhappy because we were removed from Henry’s community due to “negative behaviours and behaviours a mod should not be displaying”. Not speaking for Ahmed and Prax, but I personally am not upset nor unhappy that I have been removed from Henry’s community, but more so very bothered by how Henry is dismissing very real concerns about a predatory individual. Again, I’m not sure what “negative behaviours” Henry is insinuating here, as I have not spoken a word in his server about anything that was happening at this point.
3. Henry states that I “pulled screenshots out of context”, but I have not heard of any context that could provide valid justification to these screenshots that would prove Kazu’s intentions to not be predatory.
4. I do not want to speak on Ahmeds behalf but even if Ahmed was seen cheating and sexting, why would that be worth announcing to everyone in the server yet acts of pedophilia and statements of Trump support are easily forgiven by Henry.
5. Henry also calls us “jobless” in the statement, and has continued to call me the same in many other instances since this message. It’s important to note that I was relatively late to reading Henry’s announcement because I was at my current full-time job.
6. Henry ends the message by saying that he does not condone these “things” but it is evident that Henry does condone or at least forgive Kazu’s actions, to the point where he is actively banning community members if they speak against Kazu.

It’s also relevant at this point to mention that Henry regularly receives free food from Kazu and, according to some ex-viewers, Kazu is paying for Henry’s Spotify Premium, has bought Henry’s PC/camera, and overall has gifted Henry ~400 subs on Twitch.

Finally, the last thing I want to address is Henry’s inability to sense the seriousness of very real issues happening around him. A few months ago, Henry made and edited a Tiktok that made a joke about the ongoing ICE deportations in the States. The fact that

Henry willingly posted this while many people are living in fear and even losing lives because of ICE, shows how ignorant and out of touch he is with very real and prevalent issues. When concerns were brought up to Henry about the Tiktok, he deleted the post without addressing the community's concerns or apologizing for the post and stated that part of the reasoning why he took it down was because he didn't want to lose sponsorships.



This also further goes to show how Henry is perfectly capable of dismissing and even making jokes about very serious topics around him. This next part is more of me wanting to connect the dots, but I want to mention that Henry's willingness to joke about serious issues could stem from the fact that he consistently hangs out with Kazu since he was 18, who, as we know, have no issue with making "jokes" about supporting Donald Trump and his campaigns.

Final Thoughts

To wrap this up, I will take my own accountability in this situation and own up to the fact that I was a fake friend to Kazu and, by association, was fake to Henry. Henry was correct to say that I should have brought up this issue sooner instead of continuing to hang out of Kazu and the group. I will say that I have stopped hanging out and talking with Kazu for almost a year now, so a part of me didn't feel a need to address these concerns anymore. I will also admit that when I was hanging out with Kazu, I was comfortable with him paying for the whole group whenever we hung out and saw it as an incentive to keep hanging out with him. I'll admit in this situation that I was a fake person, and I personally didn't feel bad using Kazu's money for free stuff, especially because I was starting to lose respect for him at the time.

Additionally, I want to say that I believe Henry has good intentions in this situation. Being a loyal friend is not a bad trait and I know Henry and Kazu have been close friends for years now, so it's not surprising that Henry would attempt to defend Kazu in this context. However, I think the amount of evidence and people who share the same concerns about Kazu is worth making Henry at least acknowledge the problematic things Kazu has done. Yet, Henry continues his pattern of brushing real issues off as "jokes" or "trolling". And even though the main issue is Kazu, Henry is still the head of his community, and should know that his ignorant actions reflect upon and influence those who follow him. However, a part of me still wants to excuse this behavior by saying that Henry has been living in an echo chamber of enablement and ignorance by surrounding himself with people like Kazu, and never truly stepped out into the real world.

On the other hand, I feel very little empathy towards Kazu even now. As a grown adult who has met a lot of the community when he was 28-29, he should know better. His words, actions, and insistence on meeting up with people much younger than him (including minors), is odd and blatantly problematic/predatory. Kazu's consistent use of

money as an incentive to get others to hang out with him is also manipulative in nature despite giving the outward appearance of being “nice” or “generous”. In the end, I think Kazu knows exactly what he is doing and even though it’s not up to me, I think he should be permanently removed from the community to prevent any further harm.

Finally, the purpose of this document is not for anyone to pick a side, but to clear my name and my community’s name regarding what happened and why it happened. I want to provide as much information as I can from my point of view, but what people take away from this is up to them. I am aware that I probably didn’t cover all the context that there is, but this document is already almost 20 pages long and I can’t speak much from Henry’s point of view because we haven’t talked since he blocked me.

And to Henry, if you are reading this, you might continue to call me “miserable” and “jobless” for spending the time to type this out, but that will never change the fact that I will always stick up for my community and defend what I know is right. I really do wish you the best and I hope you can learn to step outside of your own world to see all the harmful things so many other people are seeing that’s happening in your community due to this individual. If not, then I hope defending Kazu is worth all the bridges you’ve burned.
